Round Robin Tie-Breaking Criteria

If two (2) or more teams finish the Group Stage with the same number of match wins, the final group standings will be determined using the following tie-breaking criteria, in the order listed below:

1. **Head-to-Head Result** – The winner of the match played between the tied teams will be ranked higher.
2. **Point Differential** – The team with the higher overall point differential (points scored minus points conceded) across all Group Stage matches will be ranked higher.
3. **Total Points Scored** – If teams remain tied, the team with the higher total points scored during the Group Stage will be ranked higher.
4. **Coin Toss** – If the tie cannot be broken using the above criteria, the final ranking will be determined by a coin toss conducted by the Tournament Committee.

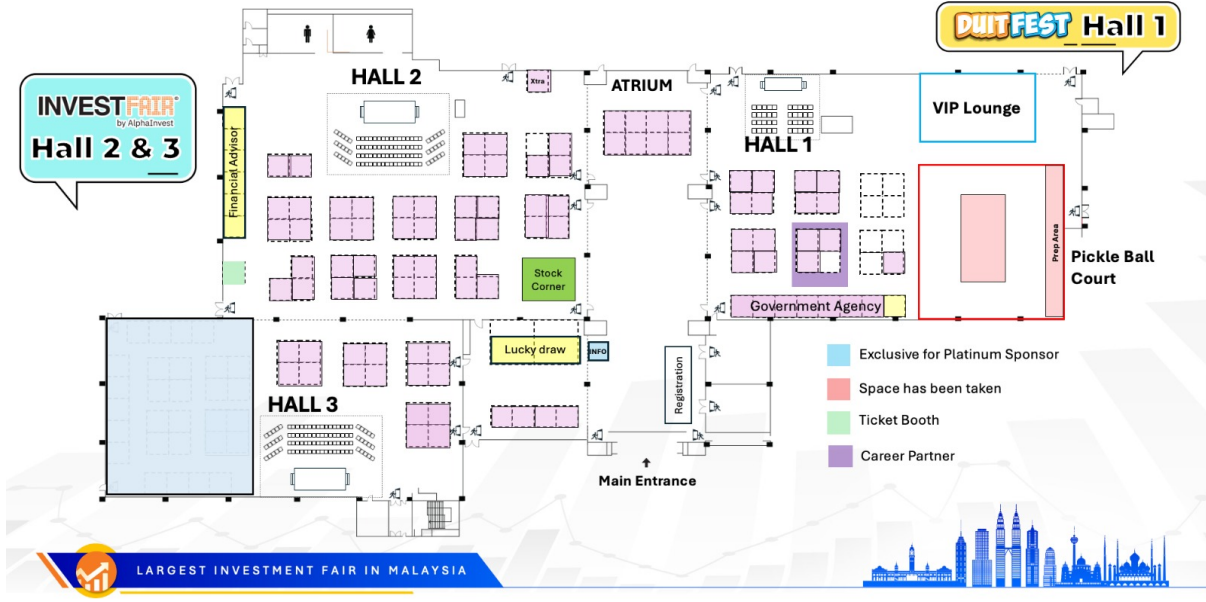

Tournament Terms & Conditions

ELIGIBILITY & REGISTRATION

1. This tournament is open to all individuals aged nineteen (19) years and above, regardless of nationality. Proof of identity and age may be requested by the organiser upon registration or at any time during the event.
2. All participants are required to have a verified DUPR (Dynamic Universal Pickleball Rating) account prior to registration. All match results will be officially submitted to DUPR upon conclusion of the tournament, and players acknowledge that their results may affect their DUPR rating accordingly.
3. Registration is only confirmed upon receipt of full payment. All payments are strictly non-refundable, except in the event of tournament cancellation by the organiser.

DUPR & SKILL CATEGORY REQUIREMENTS

4. This tournament is open only to participants holding a DUPR rating of **2.899 or below** as of the date of registration.

PLAYER CONDUCT & ATTIRE

5. All participants are required to wear appropriate sports attire and non-marking footwear throughout the event.
6. All participants are expected to demonstrate respect, fairness, and exemplary sportsmanship at all times.
7. Any form of misconduct, unsporting behaviour, or violation of fair play standards may result in immediate disqualification at the organiser's discretion.

MATCH REGULATIONS

8. All participants are required to check in at the registration counter at least thirty (30) minutes prior to their first scheduled match.
9. Player substitutions are permitted prior to the official match draw release, subject to organiser approval.
10. Line calls during regular matches are the responsibility of the competing players. Referees will officiate all matches and hold final authority on disputed calls.

11. For Semi-finals, Third Place Play-offs, and Finals, dedicated line judges and referees will be assigned. The referee's decision on all matters is final and binding.

12. Players must be present and ready at their designated court at the scheduled match time. A grace period of **five (5) minutes** will be observed, after which a walkover (WO) will be awarded to the opposing party.

13. Each player or team is entitled to a maximum injury timeout of ten (10) minutes per match. Exceeding this limit may result in a walkover at the referee's discretion.

LIABILITY & CONSENT

14. By participating in the tournament, players confirm that they are medically fit and physically capable of participating in competitive sporting activities.

15. All participants compete entirely at their own risk. While first aid services will be available on-site, the organiser shall not be held liable for any injury, loss, or damage sustained during the event.

16. By registering and participating, all players consent to the use of their likeness, including photographs and video recordings, for event promotion, marketing, and related purposes across all media platforms without compensation.

PRIZES & CEREMONIES

17. Prize winners are required to be present at the official prize presentation ceremony to receive their awards.

18. All prizes are non-transferable, non-exchangeable, and carry no cash equivalent.

19. Special cases may be considered and accepted only with prior approval from the Tournament Organiser.

GENERAL & ADMINISTRATIVE

20. The organiser reserves the right to adjust the event schedule, rules, format, or any operational matters as deemed necessary, with or without prior notice.

21. The organiser reserves the right to postpone, suspend, cancel, or modify any match, category, or part of the tournament due to technical issues, safety concerns, venue limitations, or any circumstances beyond the organiser's reasonable control.

22. The organiser reserves the right, at its sole and absolute discretion, to amend, update, or modify these Terms & Conditions at any time without prior notification to participants. Continued participation in the tournament constitutes acceptance of any such amendments.

23. All decisions made by the tournament committee are final, conclusive, and binding on all participants. No correspondence or appeals will be entertained.

Tournament Remarks

1. Group Stage

During the Group Stage, all line calls are the responsibility of the players. In the event of a dispute between the competing teams, the referee's decision shall be final.

2. Knockout Stage

During the Knockout Stage (Semi Final, 3rd Place Playoff, & Final), line judges will be assigned to officiate the matches. Players are still responsible for making their own line calls. However, if a dispute arises between the competing teams, the referee will make the final decision based on the line judge's ruling.

3. Video Evidence

Video recordings captured by non-officiated cameras, including personal mobile phones and other recording devices, will not be accepted as evidence to support or challenge any decision during tournament matches.

4. Referee's Authority

Referees are granted full authority to make final decisions on all matters arising during tournament matches in accordance with the current USAP Official Rules. All decisions made by the referee are final and binding.

5. Sportsmanship Reminder

Players are expected to treat opponents, referees, volunteers and spectators with respect. Abuse of officials or unsportsmanlike conduct may result in warnings, penalties or disqualification.
